## **WHO SHOULD COMPLETE THIS FORM?**

- Any Installer or General Contractor installing or causing to be installed, a Residential and or Non-Residential Solar PV system(s), including leased systems, in the TEP service territory.
- If your company only holds a General Contractor's license, an Installer's Packet must be submitted for all licensed subcontractors employed by the General.

## **WHY IS THIS INFORMATION REQUIRED?**

The information acquired from the "Installer's Packet" is needed for several reasons:

- To confirm the installation company holds the appropriate Business and Arizona Registrar of Contractors (AZROC) licenses (Trade Name Certifications should be provided if the company's name is different from what is reported on either the business license and or AZROC license).
- The information obtained is also used to set up your account within TEP's Distributed Generation (DG) PowerClerk tracking system. This allows TEP to associate the online application with the correct installer.

## INSTALLER CHECKLIST

The following items are required:

- PowerClerk Access Request Form
- Completed Company Approval Form (one per company)
- Copy of Business License
- Copy of Trade Name Certification (if applicable)
- Copy of AZROC License(s)
