I understand, as the authorized representative of the Property and as a TEP customer, that a rebate of up to \$400 will be credited to my TEP account after TEP's verification that all Program requirements have been met. I hereby agree to indemnify and release the TEP Parties from and against any and all claims, liabilities, losses or damages whatsoever caused by products installed at or in the Property and TEP's presence at the Property except to the extent directly caused by the gross negligence of the TEP Parties.

Program Eligibility

To participate in the program, you must:

- Be a Tucson Electric Power customer
- Install a heat pump water heater (HPWH) with a timer/controller (either included with the unit or bought separately).
- Use a licensed installer and provide proof that the work was properly permitted.
- HPWH must have been installed in current program year
- Provide proof of purchase for the water heater.
- Have the timer/controller connected to Wi-Fi with a strong signal strength
- Program the timer/controller to not operate during on-peak hours of 4-7 p.m.
- Allow a TEP representative to visit and enter your property to verify program requirements are met.

Application Process

- Please complete this application before a site visit is scheduled.
- A TEP representative will review your application for completeness and program eligibility.
- Customers with approved rebate applications will receive a credit on their electric bill.
- Rebates are subject to the availability of funding and the program is subject to change without notice.
